He is the founder and editor-in-chief of *Expert Systems with Applications: An International Journal* (published by Elsevier), and the founder and chairperson of The World Congress on Expert Systems. He has published 31 books and a multitude of articles dealing with expert and intelligent systems, knowledge management, and information technology management. His newest books are *Communicating as IT Professionals* (Prentice Hall, 2006) and *Addressing the Human Capital Crisis in the Federal Government: A Knowledge Management Perspective*, published by Butterworth–Heinemann/Elsevier (2004). He also recently completed a study on “Bridging the Knowledge and Skills Gaps: Tapping Federal Retirees” for the IBM Center for the Business of Government. He is a Fulbright Scholar, IEEE-USA Federal Communications Commission Executive Fellow, and Computer Educator of the Year (International Association for Computer Information Systems).
